


PREFACE TO CECIL COCHRANE'S NOTEBOOK

This chart provides just enough detail for reference and to show the generations (*in Roman Numerals*) and how the land and property at Edenmore¹ was passed down (*in Green*). In two generations (II and IV), Edenmore was passed from brother to brother as the eldest brothers died unmarried.

PREFACE TO THE 1st (ELECTRONIC) EDITION

Cecil Cochrane's Notebook, which was probably written over a period of years up to c1910, is an important source of information about the Cochranes in Ulster from c1690. He had access to the small number of surviving primary sources and included relevant transcripts in his notebook. These documents now seem to have been dispersed amongst various branches of the family and are no longer easy for a genealogist to get hold of. Throughout this booklet, the author of the earlier Notebook², Robert Cecil Cochrane (11th May 1871 - 24th October 1925), will be referred to as Cecil Cochrane, as he was known. Gail Henderson, who was Cecil Cochrane's great-niece and my sister, has written her own more detailed notes on the 6th Generation and beyond, thus covering the period after Cecil's death. Where appropriate, I have combined Gail's and Cecil's texts. However, Gail's notes are included in their entirety in Appendix 3.

My comments on and additions to Cecil Cochrane's text are easy to spot and generally appear as explanatory footnotes, since the original notebook did not contain any footnotes. One significant problem is that there are so many Cochranes with the same Christian name that I have suffixed their generation number in Roman numerals, for example John (III), even when quoting from old deeds; although, of course, these numbers did not appear in early documents and, be warned, my first generation is one generation before Cecil Cochrane's generation numbering scheme; in my case starting with John (I) and William (I) Cochrane of Greenhills (c1690-c1755); see Chart opposite. In the very few cases where I have noted something in the text (for example where a word is illegible) my additions always appear in square brackets and italics *[like this]*. The spelling of Cochrane has been standardised, except where an old document is being "quoted". Finally, formatting and indentation have been added to make it easier to follow from one generation to another.



INTRODUCTION

The Cochranes came to Ulster as part of the Plantation, which occurred gradually after about 1610. *[This section will be written later – do not try to translate the fake Latin]*. This map is about 7 miles wide, with the journey from the Cochranes to the Styles about $5^{1/2}$ miles and from the Cochranes to the Kincaids about $1^{1/2}$ miles. These families lived on the south side of the River Finn.

EARLIEST EVIDENCE FOR COCHRANES IN DONEGAL

FIRST EVIDENCE (1741)

The first documentary evidence of the presence of the Cochranes in Co. Donegal is contained in a deed dated 27th April 1741 showing how they became possessed of Edenmore.

The following is the extract:

Vol 154 page 199 Memorial No 103379 registered 30^{th} May 1752 of lease dated 27^{th} April 1741 by Oliver McCausland of Strabane, Co. Tyrone, Esq. to John (I) Coghran and William (I) Coghran both of Greenhills, Co. Donegal, farmers, for the lives of the two lessees and Thomas Finney son of Thos Finney of Urney renewable for ever at £35-16-6. The Farm of the east and west divisions of Edenmore in Stranorlar Manor in Co. Donegal as lately mapped out by William Starrett. Witnesses – Marcus McCausland of Daisy Hill, Co. Londonderry, Esq. – John Ferguson of Strabane, Co. Tyrone, Apothecary – Jas Miller of Lifford, Co. Donegal, Gent.

Memorial signed 22nd March 1752 by both Cochranes.

SECOND EVIDENCE (1761)

The second³ evidence is in a manuscript book⁴ found in Lifford Jail entitled Register of Freeholders of the Co. Donegal dated 1761 in which John (II) Cochrane was registered as the Freeholder of Edenmore.

THIRD EVIDENCE (1771)

The third³ above evidence is a Deed of Conveyance⁵ for 200 years of the house and lands of Edenmore, Stranorlar to John (II) and Zacheus (II) Coghran of Edenmore, Co. Donegal in June 1771.

From these facts, descent is claimed from John (I) Cochrane of Greenhills who was the original lessee of Edenmore; and John (II) and Zacheus (II) Cochrane of Edenmore (mentioned in the 1771 Deed) were, it is presumed, his sons as they succeeded to his property.

At that period, records of births, marriages and deaths were very carelessly kept and in many cases no records were available.

The property of Edenmore with an old house on it was sold by trustees of John McCausland in order to pay off family charges on the property and came into possession of this family through the Maxwells of Birdstown, one of whom married the only daughter and heiress of a certain Peter Benson to whom it had been granted to in 1630 (see "Inquisitionum in officio rotulorum cancellariae Hiberniae asservatarum repertorium" vols I-II).

It is apparent that both John (II) and Zacheus (II) Cochrane were, before 1771, tenants or lessees of Edenmore, as it is recited in the Deed of Conveyance "John (II) and Zacheus (II) Coghran both of Edenmore". Also, before this, a John (I) and William (I) Coghran lived at Greenhills, Co. Donegal. Greenhills is a small farm, now the site of the Manse, Stranorlar. There is also a Green Hill in Co. Tyrone near Castlederg on the road between Killeter and Killygordon.

There is no documentary evidence, at present found as to where John (II) and Zacheus (II) Cochrane were born. In Stranorlar Churchyard and amongst the Cochrane tombs is found one engraved as below *[Tomb 5]*, but so weather worn that part of the lettering is completely obliterated:

HERE LIES ELIZABETH COGHRAN ALIAS NEILY WIFE OF WILLIAM COGHRAN OF EDENMORE STRANORLAR WHO DIED ON THE 9TH MAY 17++ ALSO FRANCES +++ DAUGHTER TO THE ABOVE WHO DIED YOUNG

The obliterated portion is shown in red with imaginary dates, etc. Probably the wife of Rev Joseph Kincaid and sister of Anna Maria Kincaid who married John (III) Cochrane in 1790.

It is impossible to state whose tombstone this is as all the important dates and names are obliterated. But it may be assumed it either belongs to John (I) or William (I) Cochrane originally of Greenhills or William (II), younger brother.

Edenmore is in the Parish of Donaghmore and there is no trace of this family amongst the Parish records which only date from 1824. But as all the older records were sent to the Record Office in Dublin, it is possible that if there are any records extant, they would be there. In the event of a search

for the births, marriages and deaths of any of the older Cochranes being undertaken, the records of the parishes of Donaghmore, Stranorlar and Killydonnell near and under Rathmelton should be searched. (Donaghmore for the marriage of Coghran to Elizabeth Neily or Neilson and Donegal for the marriage of Zacheus Coghran to Catherine Crawford).


Arthur William Stewart Cochrane (Rouge Croix of the College of Arms, London) has made repeated searches for Wills but without much success. One interesting fact was that a Zacheus Ferguson lived and died in 1724 at Ballynacor (opposite Edenmore), one of the executors being a James⁶ Cochran and it is believed that Zacheus (II) Cochrane's father probably married a Miss Ferguson. In the Chapter House of Londonderry Cathedral there is a photo of an address to King William and Queen Mary signed by the Governors, Officers, Clergy and other Gentlemen in the City and Garrison of Londonderry dated 29th July 1689 – (this was first seen by Cecil Cochrane in August 1919). The following are amongst the signatories:

Jean Cochran (her mark) Elizabeth Cochran Thomas Coghran *[illegible]* Coghran

It is quite possible that one of these was the grandfather of John (II) and Zacheus (II), since if he was in the district, owing to the disturbed state of the country, he must have gone to Londonderry for safety and would be in the siege. Assuming that one of these Cochranes were 33 years of age during the siege, he would be born in 1656. He could have a son born about 1690 (buried in Stranorlar Churchyard) and John (II) and Zacheus (II) of Edenmore could be his sons.

An imaginary tree might therefore read:



Extract from D'Altons History of Ireland (Vol IV page 396):

"By the end of the month all Co. Down and Co. Antrim were in the hands of the Jacobites. Of the enemy (ie Protestants) some got protection from Hamilton, others fled in terror to the seaports and took shipping to England; a good number took refuge in Coleraine. Thither they were pursued and Coleraine was abandoned as was Dungannon and Omagh; and from all quarters the Protestants fled to Derry as to a City of refuge".

It has been handed down by the old members of the family that the ancestors of the family came from near Rathmelton and from Scotland to that place. It appears that in the year 1771 the Cochranes were Yeomen Farmers of a good class; this is presumed from the deed of conveyance in which they are described as Gentlemen in comparison to John McCausland (the then owner of Edenmore) who is described as Esquire and also that as they were able to buy Edenmore then for £1,323 it must be presumed that they were well-to-do.

THE 2ND GENERATION

John (II) and Zacheus (II) Coghran of Edenmore are described in the deed of Conveyance as gentlemen and they must at that time (1771) have been about 50 years of age, as Zacheus (II) married the eldest daughter of Hugh Crawford of Drumark and she was born about 1725. Both the brothers lived at Edenmore and farmed. The elder brother John (II) died unmarried in 1778. There was a younger brother William (II) buried under tombstone 37 *[Tomb ?]* who was father of James (III) Cochran who married Mary Crawford and was grandfather of Sarah and Elizabeth Cochrane of Stranorlar. There were also two sisters, one married a Kincaid, the other died unmarried.

After the death of John (II) in 1778 the house and lands of Edenmore became the sole property of Zacheus (II) Coghran. John's Will was made 18th November 1776 and proved 16th January 1779 and is as follows:

John (II) Coghran of Edenmore Co. Donegal gentleman, to his brother Zacheus (II) Coghran of Edenmore his interest in Edenmore in Stranorlar Manor in Co. Donegal and to executor $\pounds 5$. To brother William (II) Coghran of Edenmore Co. Donegal $\pounds 100$ and to nephew James (III) son of said William ... nephews William and Zacheus and Robert Kinkead and nieces Anne and Frances Kinkead ... younger children of Rev Joseph Kinkead, all nephews and nieces under 21 and unmarried — Witnesses Gust Henderson, Isaac Armstrong, Alec Purviance. Probate to executor.

Zacheus (II) Coghran married⁸ about 1760, Catrean (Catherine) Crawford eldest daughter of Hugh Crawford of Drumark and had issue:

John (III) Cochrane born 1762, married 1790, died 1831.

Anne Cochrane who married Dr John Kincaid.

Hannah Cochrane died unmarried about 1843.

It appears that Zacheus (II) died intestate and the house and lands of Edenmore became the property of his son John (III) but James (III) (son of William) remained living at the old house (near the site of the then barn on the back avenue). John (III) building about the year 1790 when he was married the lower storey of the present house and which he increased by adding another storey in 1824.

The 3^{RD} Generation

<u>John (III) Cochrane</u>, at a later date, made some arrangement with James (III) (son of William) by which the latter left Edenmore (probably paid out his father's legacy under the Will of John (II)). John (III) bought Drumhallagh estate about 1830 out of monies saved by Joseph Zacheus (his son) by farming at Edenmore and when he died left Drumhallagh to Joseph.

Albany Avenue Leasehold House property in Monkstown, Dublin was also bought by him. Hannah daughter of Zacheus Coghran was left a legacy of £500 under his will and continued to reside in the house with her brother John (III) and her nephew John (IV) until her death. John (III) married Anna Maria daughter of the Rev Joseph Kincaid of Kilcaddan and Raphoe and had issue:

<u>Frances Cochrane</u> born 1795, married 1811 Charles Style of Glenmore, died 1875.

John (IV) Cochrane born 1797, died unmarried 1860.

Joseph Zacheus Cochrane born 1799⁹, died unmarried 8th December 1881.

James (IV) Cochrane born 24th December 1801, married 1829, died 29th July 1887.

Henry Stuart¹⁰ Cochrane born November 1803, married 18xx, died 1887.

William Cochrane born 1807¹¹, died 18th July 1823.

Catherine Cochrane born 18xx¹², died unmarried 1844.

John (III) was a JP for the County Donegal and appears to have taken an active part in the Yeomanry movement and suppression of the Rebellion of 1798. He was presented with a Silver Cup in July 1801 with the following inscription on it:

"We Non-commissioned and Privates of the Loyal Fin Water Corps of Yeomanry presented this cup to John Cochran Esq. congratulating him on his well merited promotion to the rank of Captain also as a testimony of their affection and gratitude for his unwearied attention to the Corps and his distinguished steadiness during the Rebellion of 1798. Presented July 11th 1801."

This cup together with a silver tea set was taken over by the trustees of the James (IV) Cochrane estate on the death of John (V). It was purchased by

Robert Cecil second son of John (V) in 1905 and was handed over to John Ernest in 1914 on the outbreak of the 1st World War for the same figure he had paid for it. In the Library of the Irish Academy a book called "List of Officers of the Gentlemen and Yeomanry Cavalry Volunteers and Infantry 1804" (a sort of Army List), shows Fin Water (Loyal) Cavalry:

CAPTAINS	{	Henry Stewart – 31 st Oct 1796 John (III) Cochrane – 3 rd Nov 1800
Lieutenants	{	J Kinkead <mark>13</mark> – 13 th Dec 1803 John Johnston James Taylor

No other records have been. found relative to this Corps but as far as one can ascertain from local tradition the Loyal Fin Water Corps was a troop of Yeomanry raised about Stranorlar and in this troop John (III) was a lieutenant and in 1800 promoted Captain. A review of the Yeomanry was said to have been held in the year 1798 in the Holme at Edenmore.

John (III) died 20th August 1831 aged 69. He and his wife were buried in Stranorlar Churchyard *[Tomb 1]*. Under his Will dated 31st July 1831 he left to his eldest son John (IV) and his heirs the house and lands of Edenmore subject to certain bequests.

James (III) Cochrane son of William Cochrane married¹⁴ Mary Crawford and had issue:

James Cochrane who went to America.

Mary Jane Cochrane married John Wallwood, Stranorlar, d 1839 sp.

Elizabeth Cochrane born 1806, died unmarried 1886.

Ann Cochrane born xxxx, died June 11th 1843 unmarried.

Sarah Cochrane born 1825, died unmarried 1889.

This branch of the family is now extinct except any issue of James who went to America about 1851 and of whom all trace was lost. He was unmarried when he left for America and was said to have been wild.

On the death of John (III), his sons John (IV) and Joseph continued to reside at Edenmore, both of them died unmarried and were buried in Stranorlar Churchyard [*Tomb 12*].

The 4^{TH} Generation

<u>John (IV) Cochrane</u>, who was Land Agent to the Earl of Leitrim and the Harvey Estate, bought Treanamullin and Roosky¹⁵ about 1850 and left these properties entailed on his brother James and his issue.

<u>Joseph Zacheus Cochrane</u> succeeded to a life interest in Edenmore, James a life interest and his eldest son in tail; both properties being subject to bequests.

On the death of Joseph Zacheus in 1881, James (IV) succeeded to his life interest in Edenmore subject to bequests under the Will of John (IV) and he conveyed his life estate to John (V) in 1883. Drumhallagh estate was left to the Trustees to sell and pay debts and legacies and the residue to Henry Stuart for life and then to Henry Edward.

During the life time of John (IV) burglars broke into Edenmore in order to steal some collected rent placed for safety during the night in an old writing chest. The burglars were attacked by John McNaught (servant at Edenmore) with the sword used by John (III) of the Fin Water Corps and. after a tussle the burglars cleared off minus the money but with the sword which was not recovered.

<u>James (IV) Cochrane</u> born in 1801 qualified as a Solicitor but it appears he hardly ever practiced being made Clerk of the Peace for the County Donegal in 1829.

He obtained the lands of Rossgull in the following manner. A man called Allen then owner of Rossgull owed James Cochrane a considerable sum of money about £800 for money lent and secured the sum to James Cochrane by a mortgage on the property. James (IV) Cochrane in the year 1845 bought out the equity of redemption from Allen.

At first James (IV) resided at Gortlee near Letterkenny and about 1839 came to Croghan House Lifford. The 5^{TH} Generation – John Cochrane (V)

John (V) Cochrane was born at Gortlee, Letterkenny on April 9th 1834. MA of Trinity College Dublin and JP for the Counties Donegal and Tyrone. Land Agent to the Earl of Erne (Donegal property), the Harvey and other small estates. On his father's resignation in 1872, he was appointed Clerk of the Peace for the County Donegal and in 1883 his father conveyed to him his life estate in Edenmore and on his death he succeeded to Treanamullin and Roosky. He died at Combermore, Lifford on April 27th 1901 and was buried in Lifford Churchyard. On his death, Edenmore was taken over by the trustees of the James Cochrane estate. His eldest son John Ernest succeeded to the properties of Treanamullin and Roosky as tenant in tail in possession.

He married (1st) Emma Elizabeth daughter of the Rev Robert Warren, Crookstown House, Co. Cork by whom he had issue (both dying in infancy):

APPENDIX 2 - CREST, COAT OF ARMS & MOTTO

It also appears that the Crest, Motto and Coat of Arms of the family living at Dundonald was first used by John (III) Cochrane of Edenmore between the years 1803 and 1831. The exact date of the first appearance of the crest, etc is unknown. Why these were assumed, it is difficult to imagine. It may be either that having the same name, they considered that sufficient justification or that the family were actually descended from one of the branches of the Dundonald family but of this I have not been able to collect any evidence. In 1860 the Ulster King of Arms wrote to John (IV) offering to confirm the Coat of Arms, etc with a suitable difference but on account of his death no action was taken. However, in 1907 a differenced Crest and Coat of Arms was registered²⁸ to the descendants of James Cochrane as follows:

Crest: Horse passant Gu – its dexter fore hoof resting on a harp Or.

Arms: Per Chevron crenelle Arg and paby of six ermine and gules, in chief two boars Heads erased of the last.

Motto: Virtute et labore

Appendix 3 – Gail Henderson's Notes on the 6^{TH} Generation

(1) JOHN ERNEST CHARLES JAMES COCHRANE. Born in Lifford on Good Friday 15th April 1870. He was baptised in the Parish Church of Clonleigh by the Rev John S McClintock on Sunday 29th May 1870, and his God parents were C Little; CS Cochrane and JE Cochrane. He was educated at Sherborne and went to Trinity College Dublin. Here he idled for many years before finally getting his BA.

In about 1894-96 he joined the Donegal Artillery which took him out to Lagos (27th July) and he later lived out there with his first wife. He is mentioned in dispatches: 1900 "In the attacks on the Fort at Kumasi on April 29th, Assistant Inspector JE Cochrane, of the Lagos Hausas, who had arrived after two day's severe fighting, was severely wounded at Assagu outside Kumasi". Sir Frederic Hodgson mentions him in his dispatch as "having displayed conspicuous gallantry". In the same year he left Africa for London on the Victoria, because he was wounded (see letter from him written at that time).

In 1901 he was awarded the DSO for his gallantry at Ashanti. In the 1st World War he commanded an artillery brigade at Gallipoli and in France. He also went out to Spain. Eventually he came home where he worked in London as an engineer, although he had no training in this field, but his wife had plenty of money to keep him.

In 1897 he married Eileen Mary Fotrell, eldest daughter of George Fotrell Esq., Clerk of the Peace for Co. Dublin. However this marriage was dissolved in 1924. In that same year he married Katalin Louise Margaret de Szilassy, daughter of Julius de Szilassy of Soressex, Bex, Vaud, Switzerland. He lived in Switzerland with Katalin for the remainder of his life, and died there on 18th March 1938.

His first wife Eileen remarried Lt-Col Stanley-Gubbins DSO, OBE and she died on the 11^{th} December 1960.

Katalin also remarried after her husbands death, an Edward Haussman. She lived with him in America until her death in 1964.

He had two sons by his first marriage:

Douglas Ernest Cochrane, born $11^{\rm th}$ October 1901 and died $7^{\rm th}$ December 1901.

Harold Hubert Cochrane, born 11th October 1901.

(2) ROBERT CECIL COCHRANE. Born in Lifford on Thursday 11th May 1871. Baptised on Sunday 25th June 1871 by the Rev William M Edwards in the Parish Church of Clonleigh. His God parents were Dr R Little MD, DC Cochrane and H Little.

He was educated at Armagh Royal School and some other Public School in England. After his schooling he grew up at home doing nothing. He apparently carried on with some Lifford village girl, so he was sent to Canada. where he worked on a ranch. He returned home to Ireland when his father died in 1901. He borrowed money from a local man, a certain Robert Wilson, to put himself through the Veterinary College of Trinity College Dublin, and he later paid back the money. He joined the AVD and worked in Maritzburg, Pretoria and then India. In 1914 he returned from India and joined up in the Veterinary Corps during the 1st World War, and at this time he was living at Woolwich. In 1919 he went to India again before returning to Woolwich where he worked after the war. He retired to Droitwich where he got cancer of the cheek, thought due to a tooth extraction. He died on the 24th October 1925. On 9th June 1903 he married Lily Holmes Tennant, third daughter of the late Oliver Tennant Esq. JP of Esslemont Hurst, Bethlehem, ORC²⁹. They settled in Pretoria after their marriage and she died on 21st June 1951. They had issue, one daughter and one son:

John Esslemont Cecil Cochrane, born 17th April 1904 and died 31st December 1904.

<u>Margaret Gladys Cochrane</u>, born 16th February 1907 in Pretoria and died on 28th June 1934. She married Robert Stanley Harper and had two daughters by him.

(3) EDWARD WEBBER WARREN COCHRANE. Born in Lifford on Thursday 2nd May 1872. Baptised on Sunday evening the 30th June 1872 in the Parish Church of Clonleigh by the Very Rev Dr Alexander Lord Bishop of Derry and Raphoe. His God parents were J Cochrane, J Cochrane and MS Warren.

He was educated at Sherborne Public School and went on to Trinity College Dublin where he gained a BA and a MD. He joined the RAMC and became a Lieutenant in 1896, a Captain in 1899 and later a Colonel. He worked abroad and at home and was in India in 1898. He lived at Alderhurst while in England, and in 1913 lived in a house in Enniskillen for a year.

On 17th August 1914 he went off to the 1st World War, during which time he worked out in Mesopotamia doing a marvellous job organising three

hospitals. He is mentioned in two dispatches. After the war he spent a few months in Egypt and in 1919 went to India for two years. In 1921 he returned home again to live in England. He went out to Mesopotamia again in 1933 where he became ill after six months and died later in hospital in England on the 29th November 1933.

On 15th January 1910 he married Phyllis Goddard (died 13th August 1968), daughter of Joseph Goddard JP of the Manor House, Newtown Harcourt, Leicestershire and soon after their marriage they sailed for Bermuda. He had issue, one son:

John Peter Cochrane, born 15th October 1913. He was educated at Wellington school and Sandhurst. However during the 2nd World War he was a conscientious objector and acted as a stretcher bearer. After the war he joined Toothes Gallery where he became a Director of it. From a newspaper cutting in 1959: "In this chaotic age you must expect artists to express chaos in their work" said Mr Peter Cochrane. a director of the Gallery; "my eleven year old son paints some good pictures, but the difference between his work and that of other artists is the difference between good furniture and reproduction furniture. If you know the difference you can tell. But you must take the time to learn". He married twice. His first marriage on 16th May 1941 to Olga D'Ovly-John, daughter of the late Don Enrique Perez Triano-y-Memosalbas and Dona Mathilde (a woman seven years older with a 21 year old son called Gavin). This marriage was dissolved and he married secondly Petruska Corninio, daughter of the late Prof Albert Paul Corninio of Liege, Belgium and by her had two children:

Gavin St.John Warren Cochrane, born 28th December 1949 Cara Anne Fiona Cochrane, born 28th April 1956.

(4) ANNIE FRANCES COCHRANE (Nancy). Born on the 30th August 1873 in Lifford. Baptised in the Parish Church of Clonleigh on 26th October 1873 by the Rev JS McClintock and her God parents were C Little; FS Cochrane and MF Keane.

She devoted most of her life in looking after her mother, where her father died in 1901. She was educated by a governess, the Prior School Lifford and Seascale School, Cumberland, until she was 17. She was living at home in 1901 when her father died., and when Combermore was sold in 1903, she lived with her mother in a house in Lifford called Murvagh. At some stage probably when she was at home, she was engaged to a doctor in Dublin for six years! In 1910 she went down to Limerick to work as a governess for a family, but in November of that year her mother had a stroke, and she returned home to look after her. In 1913, lack of money forced her to seek a job, she went down to Culmore House outside Londonderry where she worked as a superintendent training young girls for domestic purposes. In 1914 she brought her mother down to Culmore with her in order to look after her. There was much travelling from Derry to Lifford. In 1920, she left Culmore House for good and by 1921, they settled in Murvagh, Lifford, a house bought for them by Hugh and the elder brothers. She lived there the rest of her life, sharing and running the house for her other sisters, Nora and Vi and sometimes Stella. Laterally she had cancer, but she died of a thrombosis on the 16th January 1959 at the age of 85. *"She was a life long member of Clonleigh Parish Church and until recently was a member of the choir. She was among the first ladies in Ireland to become a member of the Select Vestry. She was keenly interested in the work of the British Sailor's Society and was one of the founder members, and held office on the Strabane and Lifford Guild".*

(5) HUGH CRAWFORD COCHRANE. Born in Lifford on Wednesday 26th August 1874. Baptised in the Parish Church of Clonleigh on Sunday 25th October 1874 by the Rev Benjamin Friel Foster Dane. His God parents were R Crawford, JS Little and J Humphrey.

He was educated at All Hallos School Devon and later at Trinity College Dublin where he qualified as a solicitor. He practised in Lifford, and became agent to Lord Erne's estate in 1917, a position he held until his death in 1943.

From a newspaper cutting (no date, but about 1901): "Mr Hugh Cochrane, solicitor, will succeed his father, the late Mr John Cochrane, Combermore, Lifford, an agent of the Earl of Erne. The tenantry, it is understood, the day the late Mr Cochrane was buried, of their own accord forwarded a request to the Earl of Erne asking that young Mr Cochrane might be appointed. His Lordship replied as follows to one of the tenantry: 'I am in receipt of yours of the 6th inst., and am glad to learn that the late Mr Cochrane's many good qualities were so warmly appreciated by those among whom he lived and worked. You will have heard that I have appointed Mr Hugh Cochrane in his place. It has given me much pleasure in so doing to have been able to meet the generally expressed wish of the tenantry on the Lifford property. Yours faithfully – Erne'''. From 1917 until 1943 he was Under-Sheriff for Co. Donegal. In 1922 he came under the Ministry of local Government.

He was a gentleman jockey from 1901-1913 and also a keen cricketer, being Captain of the Strabane XI. In 1912 he married Lucy Cameron Boyd, eldest daughter of Dr John Boyd MD, Lifford. She was born on 27th July 1884, died on 13th October 1956, educated at Rosemeath Girls school, Wrexham and had one year's Froebel Training before her marriage. In 1918 she started a Girl Guides Company in Lifford, and died in October 1956). Hugh

Cochrane died on the 7th May 1943 after a short illness in Dublin. "*Mr* Cochrane who had been ill for about a fortnight, passed away in Dublin hospital yesterday morning. He was an outstanding personality and by his death the community has lost one who was a beloved and highly respected gentleman in every sense of the word. A son of the late Mr John Cochrane".

He had issue, two daughters:

<u>Jean Crawford Cochrane</u>, born 27th June 1914. Educated at Ashleigh House School, Belfast and Trinity College Dublin where she got an honours degree in Modern History and Political Science, also a MA of TCD. She trained as a teacher and taught at various schools from 1939-1956. In 1956 she became Principal of PNEU school by correspondence and in 1966, she became Headmistress of Ashleigh House, Belfast.

<u>Phyllis Doreen Cochrane</u>, born 24th December 1916 at Lifford. Educated at Ashleigh House and in 1934 she began a masseuse training at Nutsford. She had a weak heart and in 1935 she got pneumonia and after two days illness at the Cottage Hospital, Nutsford, she died on the 25th February. She was buried in Wrexham.

(6) LEONORA JOSEPHINE COCHRANE. Born on 11th November 1875. Baptised privately at Combernore on 23rd January by the Rev BFF Kane, her God parents were JF Little, A Chambers and M Payne.

She was educated at Seascale School, Cumberland until 1893. She lived at home until her marriage in October 1902. She married Thomas Hamilton Jones Lawlor (born 13th May 1865), the third surviving son of the late JH Lawlor of Ballymena, on the 11th October at Clonleigh. The service was performed by the Rev HJ Lawlor, brother of the bridegroom and by the Rev AJ Hunter, Rector of Clonleigh. The bride was given away by her brother Mr HC Cochrane and was attended by her sister Miss Violet Cochrane, as bridesmaid. The happy couple left Strabane by the Mail for Dublin en route for Cork where they will spend their honeymoon. In March 1911, when her husband was made manager off the Enniskillen branch of the Provincial Bank of Ireland, they moved from Lifford to live there. Previously he had been bank official. On the 1st May 1913 she was left a widow and on the 20th of the same month, she moved with her two children to live with her mother in law at Kingstown³⁰, near Dublin. She did various jobs including being a school matron at Rockport and Berkhamsted Girls School from the years 1920-24. She spent much of the remainder of her life living with her sisters and mother in Lifford. In 1951 she retired to bed with hardening of

the arteries and she died at Lifford Hospital on the $3^{\rm rd}$ July 1951. She had issue, two daughters:

(i) <u>Violet Leonora Frances Lawlor</u>, born 2nd October 1903 at Lifford. Educated at Alexandra College Dublin and later at Ashleigh House, Belfast. She went to Trinity College Dublin for a few years but was sent down. She then trained as a secretary and had various jobs until 1942 when she joined the ATS. In 1948 she married Raymond Homestead Hobbs (born 1901 at Newcastle-upon-Tyne. Son of AH Hobbs JP and educated at Eskdale Prep. school. At 14 he passed into the Royal Navy but he had to leave due to illness in 1920. Commissioned into the Regular Army, Royal Northumberland Fusiliers from 1924-30. Vicemaster of Mourne Grange Prep school from 1930-40 and then appointed Army Reserve as Captain and in 1946 joined the Royal Ulster Rifles. Appointed Secretary of the RUR. Association, Regimental Committee and Editor but had to resign in 1959 due to thrombosis). She was a recruiting Officer in the WRAC. from 1951-60. Later, they both ran a confectionary shop in Cranbrook. No issue.

(ii) <u>Lucy Elizabeth Cecilia Lawlor</u>, born on 9th March 1905 at Lifford. Educated at numerous school in Ireland. Trained for nursing at St. Mary's Paddington from 1926-30 (bronze medal for 2nd place in her year). Midwifery at East End Maternity Hospital and afterwards worked at the Radium Institute for six months and again at St. Mary's. She went out to the Sudan Medical Service as a sister and worked for one year before her marriage in 1932 to Robert Boog Watson Bannerman (born 1902, 2nd son of Major General WB Bannerman and Helen Boog Watson. He joined the Sudan Irrigation Dept. in 1927 and retired from it in 1950. He worked for three years in Gambia doing Irrigation and then joined thee British Civil Service in Ministry of Housing Dept. as a hydrologist, and a member of the Water Reserves Board, living in Cranbrook). They had issue, a son and a daughter.

(7) VIOLET MARGARETTA COCHRANE. Born 9^{th} December 1876 at Lifford.

Baptised in the Parish Church of Clonleigh on 25th February 1877 by the Rev AJ Hunter, her God parents were Rev HS Cochrane, M Herrick and P Kirchoffer.

She was educated at Armagh (when she was staying with cousins, the Bowmans), Steelfield Hall and Seascale, Cumberland until 1894. She also went to school in France at Tarnetgarnee. She trained as a Maternity Nurse at the Rotunda Hospital, Dublin, and most of her early work was as a maternity nurse. She returned home, but when her father died she was forced to earn her own living. She taught privately for several years in England, Ireland and Wales, including the Seagrave family from Limerick. In 1915 she became matron of the Masonic Girl's School, Dublin, a position which she held until about 1924. In 1925 she had one eye removed as it was causing so much pain, thought to be the result of a tennis ball in her eye several years before.

In 1925 she found herself a job in South Africa where she was a companion to a slightly mental person. This was in Capetown for about two years. She then went to Durban for three years, where she worked in a hostel with girls "who had had a slight mishap". In 1930 when her mother was unwell she returned home again, but the following year went out to South Africa, this time to nurse a certain Judge Benjamin who was paralysed. She went back to Durban for three more years to do a similar type of job with girls in a hostel. In 1935, she returned home for good and lived in Murvagh with her sisters and laterally alone until 1967 (aged 90) when Murvagh was sold and she went over to England to live in an old peoples home, and Vi and Cecilia looked after her.

She was a tremendous, cheerful old character [although, with her staring glass eye, she was a rather frightening sight to her young great-nieces and great-nephews].

(8) SYDNEY AUGUSTUS COCHRANE. Born on Friday 7th January 1881 and baptised in the Parish Church of Clonleigh on 23rd March 1881 by Rev Henry Hunter. His God parents were A Bowman, Augustus Warren and RA Wilson.

He was educated at a Prep. school in England and Coleraine Institute and when he finally came home from his schooling he was no longer a gentleman due to the rough manners he had learnt at Coleraine. From a 1900 newspaper cutting: "*Mr Sydney A. Cochrane, fifth son of Mr John Cochrane, Clerk of the Peace for Co. Donegal, has joined the Irish Imperial Yeomanry and, having passed the standard, has proceeded to the Curragh for training with the* 2nd *Company, prior to his going South. He is a well known horseman, and has ridden at the Caricklee and Enniskillen meetings. He is very popular amongst his neighbours, and leaves with the good wishes of all for a successful career and safe return*". On the 26th March 1900 he set off for South Africa. He was also a gentleman jockey for a man in Capetown. After the 1st World War he got a job in the Government at Pretoria.

He had a child by a Dutch half-caste, and after she died, he adopted his daughter, Sheila Augusta who is not married but has children of her own. About 1956 or 57 he was ill in a nursing home in South Africa where he died. I cannot trace his illegitimate daughter's address, but I think he died

in December 1956. I had written to him about a year or so before he died, I cannot remember the reason, and although I have since lost the letters, I had the impression that he was very sweet, for he even sent me 10/- for Christmas.

(9) ETHEL MARY GRIZEL COCHRANE. Born on 21st March 1882. Baptised in the Parish Church of Clonleigh on 25th April 1882 by the Rev JS McClintock, her God parents were R Little, AM Cochrane and ME Cochrane. She died on May 8th 1883 of accidental poisoning and was buried in Lifford Churchyard. The nurse, thinking that she was giving her Castor Oil, gave her Carbolic instead, which was partly the mother's fault for not having the bottles properly labelled, although the nurse was supposed to be illiterate and probably could not read the label anyway.

(10) MARY ELIZABETH ROBINA COCHRANE. Born on the 15th October 1884 at Lifford. Baptised in the Parish Church of Clonleigh on 28th December 1884 by the Rev JS McClintock and her God parents were Robert Bowman, Eliza Bowman and MA Little.

She was educated at the Prior School Lifford and Rosemeath School in North Wales. When her father died she went to live at Etwall with her Uncle, due to lack of money at home. She started her Froebel (kindergarten) training there for a year. In 1905 she went out to India to stay with her mother's brother, a Charles Little, a doctor in the Indian Medical Service. Out there she met and married Harry Eastland Redman on the 26th November 1906 at Secunderabad and they spent their honeymoon at Vikarabad. (He was born in 1880 at Brighton, eldest son of Joseph Redman, a dental surgeon of Wimpole Street. He joined the 6th Battalion Royal Warwick Regiment (Militia). 1900 he went with them to S. Africa and he received a permanent commission with the 1st Battalion Royal Warwick Regiment in 1901. After being invalided home from South Africa with malaria, he joined the Indian Army 9th Deccan Infantry in 1903. He served with them until he retired in 9 1924. During the 1st World War he saw service on the North-West Frontier and in Mesopotamia.)

They started of married life in Secunderabad and Poona and moved to numerous other Indian towns including Ahmadabad and Wellington, in 1908 they went to Singapore. In 1921 they came home to England with their family, as Harry was on leave for six months, and then he returned to India. His wife and family stayed first with his mother at Denbigh Road, London and later in Bedford. In 1923 they moved to Lifford staying in Mrs. Boyd's house while she was away. In 1924 he retired and came to Lifford, where they moved to another house in Lifford called the Anchorage. The summer of 1925 they moved to Guystown, Ballindrait and in 1920 into a house they had built in Strabane, called Glencoe. Although retired he took a keen interest in local affairs, during the 2nd World War he was an active member of the Home Guard, in which he served as a Platoon Commander; and the ARP³¹ organisation. He died of cancer of the oesophagus after two months illness, on the 3rd January 1950 and was buried in Lifford Churchyard. She lived on alone at Glencoe, sometimes visiting her daughters or having them and her grandchildren to stay. In 1956 after much pain she came to stay with her youngest daughter in Londonderry for one month and as she did not improve she went into the Bayview Nursing Home, Asylum Road, Londonderry. She finally became paralysed and died there on the 4th January 1957; her diagnosis being a secondary growth on the spinal cord. She was buried alongside her husband in Lifford at Clonleigh Parish Church.

She had issue, three daughters:

(i) <u>Lois Mary Redman</u>, born in Singapore 24th March 1910. She was educated by a governess in India and also attended various Army schools until the age of eleven. She went to a convent and High School in Bedford and finally the Prior School in Lifford.

In 1927 she went to Aldersey Hall in Cheshire to do a horticultural training but returned home the following year due to a weak heart. In 1929 she went to teach John Cochrane, the eldest son of Wilfred and Yseult and then had a job as a gardening companion to a certain Mrs. Moore at Ballygally Castle where she met Geoffrey Geoghegan who wanted to marry her. In 1931 she began a shorthand and typing course at the Strabane Technical College. In 1932, Geoffrey Geoghegan died³² leaving her all his money. In 1936 she went out to India to marry on the 27th April at Mhow, Rowland lager Blennerhassett Moriarty (born 16th May 1910 and educated at Portora Royal School, Enniskillen; eldest son of the Rev TAH Moriarty of Leckpatrick. He went to Sandhurst and joined the Suffolk Regiment. He retired from the Army in the rank of Lt-Col in 1956. He subsequently worked as a civil servant with the Ministry of Defence in the war records office at Edgware and died from a stroke when he had returned home from work to have lunch).

They returned to Bury St. Edmunds until the 2nd World War broke out. After the war they were in Germany and when he retired they settled in Edgware. In 1962, they bought a house down at Southwold, Suffolk where they had hoped to retire to. No issue.

(ii) Heather Elizabeth Redman, born in India 24th September 1913. Educated by a governess in India, the convent in Bedford and the PNEU school in Strabane. In 1930 she went to work in a fever hospital at Ealing, but let herself get so run down that she had to return home. The following year she did a secretarial course at the Strabane Technical College and worked for her uncle, Hugh Cochrane [a solicitor], in his office in Lifford until the 2nd World War broke out. In 1939 she joined up in the WAAF and was in London for a while before going out to Egypt for three years. She met her future husband in Cairo. flue to ill health she returned home in 1945, having attained the rank of Flight Officer. In 1946, May 11th, she married Wing-Commander, WH Bentley OBE eldest son of Mr and Mrs. W. Bentley of Southport. He retired from the Air Force in 1965 as a Wing Commander. He subsequently worked for the City & Guilds in London, commuting from their home in Berkhamsted, Herts. She has issue, two daughters (Diana Elizabeth and Mary Jane).

(iii) <u>Beryl Robina Redman</u>, born on the 23rd January 1917 in Simla, India. She was educated at the Prior school Lifford and Ashleigh House school, Belfast. She did her Froebel training at Ashleigh House for three years and then went to St. Mary's Hospital, Paddington where she began her nursing training. However when the 2nd World War broke out in 1939, she decided to get married. She married Robert Halley Henderson, son of George Henderson of Chester, on 10th February 1940 Her husband joined up in the Army during the war, and for the first year she followed him around England and Scotland. When he went out to East Africa in 1940, she went home to live with her parents. He had attained the rank of Major at the end of the war and returned to Londonderry, where he worked with his uncle in the City Factory. In 1966 he was appointed Director of the Men's clothing division of Tootals. She had issue, a son and a daughter, Geoffrey Halley (1942-) and Robin Gail (1947-1967).

(11) RUPERT HENRY WILLIAM COCHRANE. Born on the 10th December 1885, baptised in the Parish Church of Clonleigh on 6th January 1886. His God parents were WJ Cochrane, Rev JS McClintock and HC Cochrane.

He was educated at a Prep school in England and when his father died in 1901, when he was 16, due to lack of money he was sent to the Prior School Lifford. In 1903 he went to London, where he worked for three years. On 26th April 1906 he sailed for South Africa, and he finally joined up in the Rhodesian Police. On the 14th August 1919 he shot himself in his rooms at Gwanda, due to acute depression after a bout of Asian flu.

(12) HENRIETTA ESTELLE COCHRANE. Born on 5th May 1890. Baptised in the Parish Church of Clonleigh on the 24th June 1690, her God parents were John Cochrane, Lily Hiffernan and HN Crawford.

She was educated at a school in Bristol until 1908. Although she never took any training, she travelled much, working as a governess or looking after children. In 1908 she went to Wales and came home for a year in 1910. The following year she went to Bordeaux with a family and in 1913 she went to Canada. In 1919 she went to Egypt and in 1925 to Panama for two years. She came home at intervals and also had various other jobs in England and Wales. When her mother died in 1931 she came home once more, but shortly afterwards went to Tunbridge Wells where she worked in a boys school as a housekeeper.

In 1939, she got cancer of the breast and stayed with Phyllis Cochrane and her sister Vi came over to nurse her. She had an operation and recovered temporarily. When the 2nd World War started she went back to Kent, but returned home in 1942 as she had difficulty in breathing due to lung cancer. She remained at Murvagh where she was nursed by her sisters until her death on 12th January 1945.

(13) PHILIP ALAN COCHRANE. Born on the 7th February 1893 at Lifford, baptised in the Parish Church of Clonleigh on the 1st March 1893 by the Rev Edward O'Brien. His God parents were AF Cochrane, RC Cochrane and Dr JC Boyd MD. He died only two years later on 10th February 1895 of diphtheria. The doctor had wired to London for the medicine, but it arrived too late.

APPENDIX 4 - GRAVESTONES AT STRANORLAR CHURCHYARD

[The preceding page shows the "Plan of the Cochran Burying Ground" stuck on the inside back cover of Cecil Cochrane's Notebook. It was apparently produced by Joseph Zacheus Cochrane for James (IV) Cochrane in 1860. The following numbering scheme is based on this Plan made in 1860, and later updated. No.1 is at the top of the notebook's page and also nearest to the Church].

> SACRED TO THE MEMORY OF JOHN (III) COCHRAN ESQUIRE OF EDENMORE IN THIS COUNTY WHO DEPARTED THIS LIFE ON THE 20th of August 1831 aged 69 years. Though his CHARACTER IN THE EYES OF HIS FELLOW MEN WAS WITHOUT SPOT AND HE EXPERIENCED IN NO COMMON DEGREE THE BLESSING OF THE POOR YET THROUGH GRACE HE WAS ENABLED TO COUNT ALL BUT LOSS FOR KNOWLEDGE OF A CRUCIFIED SAVIOUR AND WITH HIS LATEST BREATH TESTIFIED OF THE EXCEEDING RICHES OF HIS SALVATION. BENEATH THIS STONE ARE ALSO DEPOSITED THE REMAINS OF ANNA MARIA THE BELOVED WIFE OF THE ABOVE JOHN COCHRAN WHO DEPARTED THIS LIFE ON THE 28th day of November 1844 aged 78 years. 

A large folded sheet (providing four pages) gives the Residuary Account of the Estate of Charles Style. The Styles were another family intermarrying with the Cochranes, Crawfords and Kincaids.

The first page shows that James Cochrane and Joseph Kincaid were the Executors³⁶.

The fourth page (back) shows the size of the Residuary Estate, but more importantly lists the five daughters of Charles Style of Glenmore, two of whom were married.

It is interesting to look at these signatures. The lower one is from the Estate Account above, and is the signature of Jas Cochran. The upper signature (which looks as if it has been done in pencil and then traced over) comes from a chart stuck onto the



inside back cover of Cecil Cochrane's Notebook (see Appendix 4, first page). It appears at the very bottom of the page and it is not really clear whether James himself traced over it sometime after 1860 or whether R Cecil Cochrane traced over it some years later.

The front cover is missing and the above is therefore the first surviving page. Cecil Cochrane died in 1925 and his Notebook was probably written c1910. Initially, the author appears to have used only the right hand pages, but up to page 9, amendments and insertions have been added on most of the facing pages and there was evidently an intention to re-write the whole book.

A complete facsimile of the Notebook is available as a Supplement³⁷ to this booklet.

³⁷ It was originally intended to include the facsimile within this booklet, but the very large file size of all the graphic images would have made an electronic version of this booklet impracticably large to view on the Internet. When this booklet was written in 2002, the majority of people connected to the Internet using modems at a speed of 56K (56,000 bits per second). This would mean a download time of over half an hour for the full facsimile.

APPENDIX 7 – ESTIMATIONS & SPECULATIONS

ESTIMATING DATES FOR THE EARLY COCHRANES

Cecil Cochrane provides three pieces of evidence. The **first evidence (1741)** is a lease which refers to John (I) and William (I) Cochrane of Greenhills; *implying that John was the senior (older) of the two, let us assume by 2 years*. There is a separate family tree which suggests (without any evidence being given) that John I was born c1690. The lease was dated 1741 *when, if we assume John I was born c1690, John I was aged 51 and William I was aged 49*, and both Cochranes signed the memorial in 1752 and so both were alive in 1752. *The above assumptions and a further assumption that male Cochranes of that period (who were generally long lived) live to the age of 65 suggest dates for:*

John I (c1690-e1755) William I (e1692-e1757)

The **third evidence (1771)** is a Deed of Conveyance to John (II) and Zacheus (II) in 1771 where the land was sold to them by the Court of Exchequer in order to pay charges on it; see pages 6 and 10 and the John Coghran Family Tree. In the Deed, John and Zacheus are described as "gentlemen", suggesting that they were well established and more likely in the middle of their lives than young sons just starting out. There is also the evidence (from the Crawfords of Donegal) that Zacheus II was married to Catherine (Catrean) Crawford (b c1725³⁸), implying that Zacheus II would have been born about four years before her c1721. Of course, there are many examples of the husband being younger than the wife, so this assumption must be treated with care and rejected should any contrary evidence appear later. At this stage, there is no new evidence to alter the dates for John I and William I, but we can now introduce first estimates for John II and Zacheus II, again assuming that the males lived to age 65. :

John I (c1690-e1755) William I (e1692-e1757) John II (e1716-e1781) Zacheus II (e1721-e1786)

The **second evidence (1761)** is from the Register of Freeholders where John was registered as freeholder of Edenmore in 1761. Cecil Cochrane does not make it clear if there was any evidence to suggest that this was John I or John II. According to the assumptions used above in Fig.2, John I would have been aged 71 and more than likely already dead; whilst his son John II would have been aged 45 and is therefore the most likely person being referred to in the Register.

The John Coghran Family Tree gives the death of John II (unmarried) as 1778, with the Will made on 18th November 1776 and proved on 16th January 1779. This Will passed on Edenmore to his brother Zacheus II, and also mentioned:

- brother William (II)
- nephew James (III) son of William (II)
- nephews William, Zacheus and Robert Kinkead, and nieces Anne and Frances Kinkead ... younger children of Rev Joseph Kinkead³⁹, all nephews and nieces under 21 and unmarried.

This gives more information, without needing to make more assumptions, to add to Fig.2 above, particularly the fact that the various nephews and nieces were under the age of 21 in 1776 when the Will was made :

John I (c1690-e1755) William I (e1692-e1757) John II (e1716-1778) Zacheus II (e1721-e1786) *William II (e1723-aft1776)* James III (aft1755-?) *Five Kincaids (aft1755-?)* Figure 3

William II was evidently alive when the Will was made in late 1776. Whether John (who died less than two years later and was probably already ill) would have altered the Will if his younger brother William II had died between 1776 and 1778 is speculative.

³⁹ The sister of John (II), Fanny Cochrane, had married Rev Joseph Kincaid.

About the Kincaid children, we know from the Will that William, Zacheus, Robert, Anne and Frances Kincaid were born after 1755 and were not married in 1776. *Possibly, they were not married in January 1779 when the Will was proved, or there might have been a note to this effect from the Executors*.

THE TWO JAMES III COCHRANES (EST1760-EST1825)

There were two James Cochranes (cousins) who lived from the late 1700s to the early 1800s. Although they had a common grandfather (John (I) Cochrane), the two James were fathered by John's two youngest sons Zacheus (II) and William (II). One James married Mary Crawford and the other married Fanny Kincaid⁴⁰, but what is the evidence to indicate which was which?

The only known sources are:

1. Cecil Cochrane's Notebook

In writing about the 2nd Generation, Cecil Cochrane refers to "William (II) ... who was father to James (III) who married Mary Crawford".

2. The Crawfords of Donegal Booklet

The Crawfords of Donegal states⁴¹ that "Mary [*Crawford*] married James Cochrane and had issue James, Mary Jane, Elizabeth, Sarah", without indicating who James Cochrane was the son of.

3. John Coghran Descendancy Chart

This shows "James Cochrane (born 1761?) marrying Mary second daughter of James Crawford and his wife Mary Makelwaine". The original red ink link from parents "William (II) Cochrane married to Ann Dickson" has been crossed through in pencil and a new link in pencil shows "James as the son of Zacheus (II) Cochrane who married Catrean Crawford, eldest daughter of Hugh Crawford of Drumark". This same chart shows James' children as James (who went to America), Mary Jane, Elizabeth, Ann and Sarah".

4. Will of John (II) Cochrane.

John leaves property and money in his will "to brother Zacheus … to brother William … and to nephew James son of said William …". Although there is no mention of another nephew James son of Zacheus, this is not perhaps surprising, as none of his brother Zacheus' children are mentioned, since Zacheus inherited the major share, by getting Edenmore itself.

In summary:

Source 1 gives James (III_w)⁴² (from William (II)) = Mary Crawford.

Source 2 gives James (III) = Mary Crawford, and four children.

Source 3a gives James (III_w) (from William (II)) = Mary Crawford, and five children

Source 3b gives James (III_z) (from Zacheus (II)) = Mary Crawford, and five children

Source 4 gives James (III_w) (from William (II)), but does not contradict the possibility of another James (III_z) (from Zacheus (II)).

In none of these four sources is there any indication of there being two James (III) Cochranes; unless the indecision in Source 3 is some indication that there were really two James Cochranes. In <u>all</u> cases where marriage is mentioned, James (III) is stated as marrying Mary Crawford.
